B.4. Content ownership, moderation & approval policy (COMAP) (clause 5.2.1)

The Content of the Website should always be accurate and up-to date. Each content published on the website is verified and checked.

The content of the website goes through the following process:-

- (i) Creation
- (ii) Modification
- (iii) Approval
- (iv) Moderation
- (v) Publishing
- (vi) Expiry

Contents of the website are categorized as follows:

- (i) Routine
- (ii) Priority
- (iii) Urgent

Urgent contents may be uploaded immediately on the website followed by priority and routine contents. For the purpose of the Website Management Officers are categorized into five levels namely:

Level 1 – Section Officer (S.O)/ Appeal Examiner (A.E)
/ Personal Assistant (P.A)
```

Level 2 – Sub Assistant Registrar (S.A.R)

Level 3 – Assistant Registrar (AR)

Level 4 – Deputy Registrar (DR)

Level 5 – Joint Registrar (JR)

In case a particular officer is not available in the said hierarchy, the other next upper level Officer should discharge the duties in addition to his role assigned. New Links on the website can be created with the approval of the Web Information Manager. The Originating Section is the owner of the content on the Website. Correctness, accuracy and relevance of the content vest primarily with the Originating Section. The officers of the concerned section shall act as the approver and moderator of the content.

In case of those links/contents which are uploaded by the NIC, the moderators shall be the officers of the Computer Section and Approvers shall be the officers of the originating section.
